

FastTrack® End User License Agreement

FastTrack Market Data Excel Add-In ("the Software Product"), FastTrack Data ("Data") and accompanying documentation (collectively "the Service") is licensed and not sold. Investors FastTrack or its subsidiaries, affiliates, and suppliers (collectively "FT") own intellectual property rights in the Service. The Licensee's ("you", "your") license to download, use, copy, or change the Service is subject to these rights and to the terms and conditions of this End User License Agreement ("Agreement").

This Agreement describes the rights and limitations of your usage of the Service. You must accept all terms to install or use the Service .

FastTrack Data ("Data")

Data is investment security prices, distributions, highs, lows, opens, market indices, ticker symbols, issue names, and other financial information regardless of how stored or distributed. FT grants you a nonexclusive, nontransferable, limited license to use Data. Data is collected by FT and redistributed to you. Data use is restricted under the terms of this Agreement. Data may not be redistributed, modified, updated, or appended by you except under separate agreement with FT.

You acknowledge that you have no ownership of Data. Data may be used only in conjunction with the Software Product. You may not use Data in connection with any software other than the Software Product.

FT will make its best efforts to correct and errors discovered. However, FT is not obligated to match results of other sources which themselves may be subject to error.

The term of this Agreement is from the moment FT licensed materials are received by you and until such materials are removed from all of your computers, tapes, diskettes, and other computer media.

Acceptance

YOU ACCEPT AND AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT BY INSTALLING, USING, OR COPYING THE SERVICE. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, YOU MUST NOT INSTALL, USE, OR COPY THE SERVICE.

Restrictions on Transfer

You may not assign your rights and obligations under this Agreement, or redistribute, encumber, sell, rent, lease, sublicense, or otherwise transfer your rights to the Service without FT's written consent. Such consent shall not be unreasonably withheld.

Limitations

The information that FT provides is only part of the information needed for a good investment program. Consult your investment securities advisor before buying or selling any security.

FT and its suppliers shall not be liable for errors, omissions, or malfunctions in the Service, nor for damages incurred by you related to the use of the Service. The information feeds from which Data is derived are known to have errors.

Copying and Redistribution

The Service, documentation, manuals, and related materials are protected under this Agreement . Copying, modifying, or redistributing the Service without express written permission of FT is strictly prohibited. All rights are reserved.

Permitted Uses (“Permitted Uses”)

The Service may not be used for any fashion other than:

By individuals making personal investment decisions.

By individuals or investment professionals in rendering advice.

By professionals making selection and timing decisions.

By publishers (authors, lecturers, editors, electronic publishers, and web sites) for illustrating their works with historical Data.

All Permitted Uses are limited. Permitted Uses do not imply fitness or suitability of the Service for any specific or intended purpose. All works containing Data, or its mathematical derivatives, shall conspicuously display “Charts [and/or] Listings [and/or] Data by www.FastTrack.Net”. This display must be adjacent to or within each illustration, table, or paragraph.

On web pages, email and any other publication capable of click links, the attribution must be click-linked to <http://www.FastTrack.net/>

Your publications (all taken together) are limited to use of distribution-adjusted Data for less than 100 ticker symbols per month. Works may neither display any distribution/ split/ dividend Data nor derived adjustment factors. Works may not display current (as of last market close) prices or current charts, nor provide a total return for periods shorter than one month, nor can this above information be published more frequently than monthly. Redistribution of updated or modified Data or the use of Software Product with updated or modified Data is prohibited except as provided for under a separate Subscription agreement.
